
All three young attorneys have been practicing law less than ten years, yet all recognize the importance of giving back to their community. Ryan and Chris said having children of their own greatly influenced their decision to join TLC. "I know the children I am helping could be my sons' classmates, friends, and future colleagues...it is disturbing to know some of the behaviors I read about could be happening to my sons' classmates, friends and future colleagues," says Ryan. Daniel, who practices in the area of Native American law and who occasionally works on Indian Child Welfare matters, realized the need for children to have adequate representation. He says that volunteering for TLC gave him an opportunity to work directly with children and ensure their voices are heard.

TLC is particularly grateful to these young volunteers who take time out of their regular practice to represent their young clients. Chris, whose practice focuses on construction law, says it is heartbreaking to be confronted with the reality that so many children, right where we live, are forced to face extreme adversity early in their development. Ryan, who practices in the areas of energy law, employment law, and insurance defense, feels rewarded when witnessing a child/client get adopted into a family who loves, cares, and supports the child and gives his client a sense of belonging. Daniel says despite the challenges of representing a child not getting the care and services they deserve, it is rewarding to watch a child's development improve as a child's conditions at home improve. Daniel says that he also enjoys getting to play Nerf guns with his client as a TLC Volunteer!

In their free time, away from the practice of law, all three enjoy the outdoors. Ryan is a coach for his seven-year-old son's baseball team; Chris enjoys cycling; and Daniel just likes anything that gets him outside and away from the office.

Funny facts: Chris, who has been with Conner & Winters since he was fresh out of law school in 2011 actually did not ONCE consider becoming a lawyer until three months before he applied to law school. Lucky for TLC he did! Also, Ryan is an identical twin--his twin lives in Mississippi!
